What you need to bring:

- Completed application (SS-5 form)*
- Certified marriage record
- Valid (unexpired) driver's license; ID; **OR** passport
- Birth certificate; U.S. Consular Report of Birth Abroad; U.S. passport (unexpired); Certificate of Naturalization; **OR** Certificate of Citizenship



3) Next, you will take your new Social Security card and the certified copy of your marriage record to the DMV and get a new driver's license/ID.

You must change your name in person at the DMV, however they do not take appointments. You will need to bring a completed form*, your current driver's license/ID, new social security card, and the certified copy of your marriage record.

*Go to penndot.gov → Driver & Vehicle Services → Driver Services → Driver & Teen Licensing → Change Your Name or Address → choose appropriate form (driver's license or photo ID)

4) Once you receive your new driver's license/ID, you can use that to change anything else.

Other things to consider:

- Voter and car registration
- Bank accounts and insurance policies
- Leases and property titles
- Passports
- Mail deliveries
- Employee benefits
- Credit cards, stock, bonds, investments
- Wills

Copies of marriage licenses

- Regular/plain copy: (\$2 check/money order or \$2.06 credit/debit card)
 - Used for purposes that does not require court certification that the copy is authentic (Ex: genealogy)
- Certified copy: (\$25 check/money order or \$25.75 credit/debit card)
 - Required when you're changing your name on your driver's license, passport, or social security card
- Exemplified copy: (\$30 check/money order or \$30.90 credit/debit card)
 - Required for foreign governments
