

Proposed Precinct Consolidations – 2025

In January 2025, the Delaware County Board of Elections authorized staff to initiate as many as 51 consolidations of sets of smaller-than-average precincts in communities throughout the county.

Most of these sets of precincts already vote together in the same polling place. A few of these sets of precincts currently vote in separate locations that are short distances apart. The Board staff reviewed the data and verbal descriptions (legal boundaries of the precincts) to prepare petitions to file with the Delaware County Court of Common Pleas. As of July 29, 2025, the Board staff currently is pursuing 46 of the original 51 consolidations.

The proposed consolidations would replace micro- and mini-precincts to create more precincts in the range of 600-1,800 voters by combining the smallest precincts. These currently have from 195 to 1,010 voters. None of the proposed consolidations would create “larger” precincts of 2,000 or more voters.

The following pages contain the verbal descriptions of the proposed consolidations, as well as voter-registration data, a listing of the location that the voters use now, and the location of the polling place that would be used after the consolidation, and a map of the precincts as they are now.
