Motion made by Mrs. Morrone approving to renew the annual Support License and Maintenance Contract for the 2019 Management System Licenses, Maintenance and Support from Corrections Development Inc. for the term January 1, 2019 through December 31, 2019 in the amount of \$35,000.00. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving the participation in the Inter-Governmental Transfer Agreement for the period July 1, 2019 through June 30, 2020 between Fair Acres Geriatric Center (Delaware County) and the Department of Health and Human Services. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving Agreements, Contracts and Amendments with the Human Services Provider of Services as per the attached list. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving the Delaware County's share of the Delaware Valley Regional Planning Commission's Annual Contribution Agreement for the approved Planning Work Program for fiscal year 2020 in the amount of \$153,078.00. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving Agenda Item 9, the appointment of Mike Ranck, President and CEO of the Community YMCA of Eastern Delaware County, as Chair of Complete Count Committee for 2020 Census, seconded by Mr. Culp. Discussion followed. The motion was carried unanimously.

Motion made by Mrs. Morrone approving to advertise a Request for Proposals for the CAD to CAD (Computer-Aided Dispatch) Project for the Southeastern Pennsylvania Regional Task Force Regional Managers Group which is comprised of Bucks, Chester, Delaware, Montgomery and Philadelphia counties. The motion was seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving Agenda Item 11, an Inter-County Mutual Aid and Assistance Agreement between the County of Delaware and New Castle County, Delaware to provide for mutual assistance among participating political subdivisions and fire, rescue and emergency medical provider organizations in the prevention of, response to, and recovery from emergency situations as described in the agreement. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving an Agreement between the Commonwealth of Pennsylvania, acting through the Pennsylvania Emergency Management Agency, and the County of Delaware, a Sub-Recipient County authorized as a signatory of the Southeastern Pennsylvania Regional Task Force Mutual Aid and Intergovernmental Cooperation Agreements, to accept the 2019 State Homeland Security Grant Program Funds valued at \$878,960.00 for the purpose of supporting the identified planning, organization, equipment, maintenance, training and exercise needs to oppose acts of terrorism and other catastrophic events. The performance period is September 1, 2019 through August 31, 2022. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving an Agreement between the Commonwealth of Pennsylvania, acting through the Pennsylvania Emergency Management Agency, and the County of Delaware, a Sub-Recipient County authorized as a signatory of the Southeastern Pennsylvania Regional Task Force Mutual Aid and Intergovernmental Cooperation Agreements, to accept the 2019 Urban Areas Security Initiative Grant Agreement valued at \$13,520,000.00 for the performance period September 1, 2019 through August 31, 2022. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving Agenda Item 14, a Memorandum of Understanding between the Delaware County Park Police Independent Union and the County of Delaware for a wage increase for all Park Police Officer positions, retroactive to August 26, 2019. The motion is subject to the Solicitor's approval, seconded by Mr. Culp. Discussion followed. The motion was carried unanimously.

Motion made by Mrs. Morrone approving a Memorandum of Understanding between the County of Delaware Public Employee's Association Local 3107 of the American Federation of State, County and Municipal Employees, District 88 and the County of Delaware for a wage increase for all Grade 12 Deputy Sheriff and Medical Legal Investigator positions, retroactive to August 26, 2019. The motion is subject to the Solicitor's approval, seconded by Mr. Culp. Discussion followed. The motion was carried unanimously.

Motion made by Mrs. Morrone approving to Award Contract No. E-060419 to Eastern Highway Specialists, Inc. to repair the Grant Avenue Bridge over the Muckinipattis Creek in Glenolden Borough, County Bridge No. 141, in an amount not to exceed \$127,645.60. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving to Award Contract No. E-082219 between the County of Delaware and Frania Construction Inc. for the Delaware County facilities asphalt paving

repair and replacement project for a total cost of \$474,220.00. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone to appoint Mark Dambly to the Southeastern Pennsylvania Transportation Authority (SEPTA) Board for a term ending September 2023 and seconded by Mr. Culp. Discussion followed.

Motion made by Mr. Madden to "table" this item for two weeks. The motion was seconded by Mr. Zidek. Discussion followed. The motion failed to be approved by the following votes registered: 2 Yeas – Madden and Zidek and 3 Nays – McBlain, Morrone and Culp.

Motion made to approve the main motion made by Mrs. Morrone and seconded by Mr. Culp to appoint Mark Dambly to the Southeastern Pennsylvania Transportation Authority (SEPTA) Board for a term ending September 2023. The motion passed with the following votes registered: 3 Yeas – Morrone, Culp and Zidek, 1 Nay – Madden and 1 Abstention – Chairman McBlain as the law firm where he is employed has been assigned to represent Pennrose Properties (where Mr. Dambly is an officer) by insurers.

Chairman McBlain recognized Cathy Bittle, Director of Library Services, who gave an update on a project that she previously spoke about concerning the *decrease* of public internet usage of computers in the Delaware County libraries and the initiative to repurpose some of those computers with less than 45% usage.

Motion made by Mrs. Morrone approving Agenda Item 19, the request by the Controller's Office for payment of current bills, seconded by Mr. Culp and carried unanimously.

**SOLICITOR:** Mr. Maddren asked for Council's authorization to file thirteen (13) Petitions for the Termination of Parental Rights and one (1) Consent for Adoption with the Orphans Court.

Motion made by Mrs. Morrone approving to file thirteen (13) Petitions for the Termination of Parental Rights and one (1) Consent for Adoption with the Orphans Court, seconded by Mr. Culp and carried unanimously.

Mr. Maddren gave a brief update on the opioid litigation and where Delaware County stands on our efforts in that regard.

**PUBLIC COMMENT:** <u>Ken Hemphill, 1239 Mill Race Place, Glen Mills (Concord Township)</u>, commented on today's SEPTA Board appointment.

John Butler, 208 Laurel Lane, Broomall (Marple Township), commented on Scenic Byways, ESCO, tax assessment and the recent Prison Board Meeting he attended.

<u>Cathy Payne, Prospect Park Borough</u>, commented on the lack of progress being made to house the homeless animal in Delaware County and her efforts in putting a fundraiser together to help shelter these animals.

**COUNCIL:** On the anniversary of September 11, Mr. Zidek wished to thank our First Responders for all they do to serve Delaware County citizens.

Mr. Madden commented on the staffing levels by the GEO Group at the prison. He also said we need to remember the events of September 11, 2001 and the job our First Responders did and continue to do.

Mr. Culp thanked our First Responders and for all those who lost their lives on September 11, 2001.

Mrs. Morrone said her thoughts are on remembering September 11 and all those individuals who lost their lives and the families impacted on that day and continue to be impacted by that event.

Chairman McBlain echoed his fellow council member's comments regarding September 11 and hope we remember that sense of unity that our entire country had on that day and the days following.

There being no further County business, nor public discussion, motion made by Mr. Culp to adjourn the meeting, seconded by Mr. Madden and carried unanimously.
