Probation is granted with the full understanding that you are in the legal custody of the Delaware County Court until the expiration of your sentence, or until such time as you may be legally discharged. The Court has the power at any time during your period on Probation, in case of a Violation of the Conditions of Probation, to cause your Removal from the ARD Program.

YOUR PROBATION IS GRANTED SUBJECT TO THE FOLLOWING CONDITIONS:

1. You will report, in person or in writing, to the Office of Adult Probation according to instructions.
2. If you change your address or phone number during the course of your probation, you will inform the Office of Adult Probation in writing.
3. You will comply with all Municipal, County, State and Federal criminal laws, and abide by any written instructions of the Delaware County Court or the Office of Adult Probation. You are to notify this office within 72 hours of any new arrest or citations.
4. If you will be outside the state of Pennsylvania for longer than thirty days, you are to notify the Office of Adult Probation.
5. Abstain from the unlawful possession, or sale, of narcotics or dangerous drugs, and abstain from the use of Controlled Substances within the meaning of the Controlled Substance, Drug, Devise and Cosmetic Act (35P.S. 780-101 et.seq., as amended to date) without a valid prescription. **You will submit to random drug analysis and Breathalyzer tests**
6. Refrain from overt behavior which threatens or presents a clear and present danger to yourself or others.
7. You will comply with the following **SPECIAL CONDITIONS** which have been imposed by the Court:
 - i. You are subject by Order of Court to pay all fines and costs on the day of Admission to the ARD Program. You are also to pay any restitution and a monthly supervision fee of \$40.00.
 - ii. You are to complete any evaluation ordered by the Court and follow recommendations.
 - iii. You are to complete Alcohol Safe Driving Classes and any community service ordered.
