1. Obtain an application from the Delaware County Health Department (DCHD) <u>website</u> (<u>https://www.delcopa.gov/health/environmentalhealth.html</u>)

- 2. Complete the application (please type or print legibly to prevent delays)
- 3. Provide supporting documentation:
 - □ If providing food service, a copy of the most recent food license issued by DCHD or local Delaware County municipality *Separate Food Facility License is required
 - Copy of most recent License/Certificate issued by DCHD or local Delaware County municipality
 - Copy of PA Department of Health Permit to Operate a Public Bathing Place
 - □ Copy of the current Electrical Inspection Certificate
 - Copy of Certified Pool Operator Certificate or Certified Pesticide Applicator Certification in Category 24 (Swimming Pools), in accordance with the PA Code, Chapter 128 (Pennsylvania Pesticide Rules and Regulations).
 - Copy of lab results from the past 7 days
 - Current and Valid Lifeguard Certificates
