PICNIC PERMIT RULES & REGULATIONS

1. Picnic reservations are made for groups of 10 or more. Smaller groups have free choice of unreserved areas; first come, first serve.
2. Groups reporting more than one half-hour late will forfeit the reservation should others occupy the area.
3. No alcoholic beverages may be sold, brought or consumed within the boundaries of the park.
4. Discarding trash or damaging county property is prohibited.
5. No pets permitted in parks unless on a leash.
6. The use of firearms, air guns, slingshots, bows and arrows, and fireworks is prohibited.
7. No fires are permitted except in fireplaces, council rings, grills, and other facilities provided for that purpose.
8. Moon-bounces, slip-n-slides and all other objects of that nature are prohibited.
9. Operation of mini-bikes, go-carts, dirt bikes, snowmobiles, ATVs and other similar types of vehicles is prohibited.
10. No person shall sell or offer for sale any object or merchandise without written permission from the Parks Department.
11. All weddings (civil or otherwise), religious services or ceremonies are prohibited in any Delaware County Park.
