Questions #1: Since there are no drawings, are we to assume all of this is going to occur at one location?

Questions #2: Are there liquidated damages for this bid?

<u>Questions #3:</u> Is a Performance Bond, Payment Bond, or Maintenance Bond required at any point of this project? If so, what are the percentages % and warranty periods for each?

<u>Answer:</u> A payment bond does not apply for this project. For Performance and Maintenance bonds see below:

- For Performance Bonds Per Administrative Code Section 6-28, Subsection J(1) "Contracts for one year or less. Except for bids of less than \$50,000 on items under express, ninety-day written manufacturer's warranties or supplier's warranty in a form satisfactory to the Central Purchasing Department, the successful bidder shall be required to enter into a contract and furnish a bond guaranteeing performance of the contract with sufficient surety in the amount of 100% of the bid where the length or term of the contract awarded is one year or less." Such bond shall is contingent prior to the award of the bid, not part of the bid submission.
- <u>For Maintenance Bonds</u> A maintenance bond shall be required for fifteen (15) percent of the cost of the work for a period of eighteen (18) months.

Questions #4: Is a bid bond required for this project?
