# 11/26/2025 Delaware County Board of Health Meeting Delaware County Department of Health Status Report

Reporting Period: September – November 2025

# I. Executive Summary

DCHD advanced key operational and infrastructure modernization efforts, including strategic relocations to improve efficiency and reduce costs. Technology upgrades strengthened IT service management, data visibility, and EOC/AV reliability to better support public health preparedness. Despite State and Federal fiscal uncertainty, active management of complex funding streams ensured program continuity. Core programs across Community Health Improvement Plan (CHIP), personal health, and population health remained strong, even as the department navigated challenges related to collective bargaining, staffing capacity, and infrastructure delays.

# **Key achievements:**

- Office relocations are progressing as part of DCHD's broader strategy to reduce costs and support operations:
  - o Administrative Division (estimated move date end of May 2026):
    - Estimated cost savings: ~\$147,000 per year in Administration Division rent costs eliminated
    - Efficiencies gained: Administration staff co-located with the majority of other DCHD programs
  - o Environmental Division (estimated move date early February 2026)
    - Estimated cost savings: ~\$175,000 saved over 5-year lease term
    - Efficiencies gained: Environmental Health geographically centralized, reducing staff travel times and increasing convenience for some county clients; majority of DCHD EV fleet located in much closer proximity to county charging locations
- Freshservice (cloud-based IT Service Management platform) and Jotform (survey and form builder) went live in November and are now supporting ticketing, dashboards, analytics, knowledge management, and surveys across DCHD.
  - The transition from Qualtrics to these two new platforms was led by DCHD's Data Modernization Specialist and Administrator for Operations over the last year with in depth coordination across all departments.
  - o Estimated cost savings: \$143,700 per year

- DCHD will conduct a final pre-delivery inspection site visit for DCHD's Wellness on Wheels (WOW) Mobile Health Unit in December 2025. Vehicle currently scheduled for arrival at DCHD in Q1 2026; SOP development and equipment preparation underway.
- EOC (Emergency Operations Center) connectivity strengthened with upgraded Wi-Fi and Windows 11 laptops; planning for backup power and more robust partner access in progress.
- DCHD's FY 2025–2026 total available grant funding is \$7.93M; 13% spent to date, leaving significant capacity for planned activities.
- Strong performance in community engagement and service delivery through CHIP, personal health programs and Population Health outreach and preparedness.

#### **Challenges:**

A common theme across DCHD programs is the operational impact of DCHD staff members being added to an existing Delaware County bargaining unit of the American Federation of State, County and Municipal Employees (AFSCME) after an employee vote and state labor board certification in October 2025. Approximately 60% of DCHD employees are now members of the AFSCME. DCHD management is working to comply with the current collective bargaining agreement while continuing to provide consistent oversight and support to all employees. To strengthen supervisory capacity during this transition, programs report a need for clearer guidance, including a detailed outline of the existing agreement to ensure aligned and compliant personnel management.

# **II. Programmatic Updates**

# **Epidemiology:**

# Reportable & Seasonal Diseases

- **Respiratory Illnesses**: COVID-19, influenza, and RSV wastewater levels remain very low. No reports of outbreaks from long-term care facilities or schools. One croup outbreak reported in a single school.
- **Vector-borne Illnesses**: DIS staff continue to evaluate cases of tickborne diseases. Malaria (travel acquired) and tickborne diseases were investigated this month.
- **Measles:** At the request from the CDC and PA DOH, DCHD investigated two suspected Delco resident exposures to a measles case traveling by plane in November 2025. One case provided an interview and reported to be vaccinated and without symptoms. The second case did not respond to 4 calls/text messages. DCHD hand-delivered a letter to the non-respondent case's address.
- **Mpox:** None detected or reported this month (as of 11/11/25). One case each reported in September and October 2025.



# Lead in Blood Testing Portable Handheld Devices (Lead Care II Analyzer)

- From Jan to Oct 2025, 486 tests were provided from devices deployed to 7 locations and 2 events (Table 1)
- 2024 & 2025 (up to April 18<sup>th</sup>) data:
  - 1. ChesPenn City of Chester: 257 tests
  - 2. Advocare Eddystone: 163 tests
  - 3. ChesPenn Upper Darby: 57 tests
  - 4. Outreach events: 10 tests (Table 1.1)
- Preliminary estimates indicate 2% of tests had a blood lead level 10 ug/dL or higher at the two ChesPenn locations



# **Ongoing Data Analyses**

- US Government closure made it impossible to download population data needed for age-adjusted calculations for chronic diseases' mortality and Standardized Incidence Ratio (SIR) for cancer clusters. The closure caused delays of ongoing projects.
- Standardized Incidence Ratios (SIR) by zip codes are being calculated in response to a request about a breast cancer cluster in a Delco neighborhood. SIR helps to determine if a zip code (or any other boundary) has a higher, lower, or similar number of cancer cases compared to what would be expected based on county, state or national rates.
  - $\circ$  SIR > 1.0: The observed number of cases is higher than expected.
  - o SIR < 1.0: The observed number of cases is lower than expected.
  - SIR = 1.0: The observed number of cases is the same as expected.
- PA DOH has granted access to their STI dashboard which includes real-time data on STI conditions by race, age, sex, and place (zip codes).


- o Partnering with SCI Chester to provide CPR classes quarterly in 2026.
- **Mobile Health Unit Program (MHU):** MHU Coordinator scheduled to travel to Greensboro, NC, on 12/16/25 to tour the unit.


# • Public Health Emergency Preparedness (PHEP)

- The 2026 Special Events Initial Planning Meeting added the Population Health Administrator and PHEP Specialist to the Delco Planning Committee, which is preparing for major upcoming events including America 250, FIFA World Cup, the PGA, and other large regional activities.
- Delaware County Cold Plan: The updated Cold Weather Plan was finalized and shared with County partners and the Executive Director, aligning the Code Blue threshold more closely with the City of Philadelphia and removing the Extreme Code Blue designation.

- Immunization Team:
  - Immunization Clinics- (9/1/25-11/25/25)
    - Yeadon Wellness Center: 947 total vaccines administered, including 312 flu vaccines.
    - Chester Wellness Center: 62 total vaccines administered, including 2 flu vaccines.
    - Homebound Vaccine Program: 19 patients served and 25 vaccines administered since launching this year's seasonal campaign in October.

  - o George W. Hill Correctional Facility:
    - 462 STI samples tested (9/1/25–11/18/25). This represents a significant cost savings to the County of Delaware.

- Swarthmore College (September):
  - 32 students tested for STI/HIV.
- o Widener University (October):
  - 16 students tested for STI/HIV.
  - 25% of those tested were positive for Chlamydia.
  - This zip code is recognized as a high-need area due to elevated STI positivity rates.
- o Penn State–Brandywine (October):
  - Provided STI/HIV education and giveaways.



- Although the supplier list from PDA was short, EH conducted electronic search through IMS to locate all other potential suppliers in Delaware County facilities

# **Summary Insights**

- DCHD experienced significant challenges addressing cashflow and uncertainty from state budget impasse and federal grant changes and then federal government shutdown during this period.
- Overall, 13% of FY25–26 grant funding spent to date; significant capacity remains.
- DCHD reimbursements for ELC and Immunization (9-month cycle) grants pending receipt of workbooks from the state.
- DCHD grant programs for Mosquito Borne Disease Control and HRSA Health Equity show high utilization and active engagement.
- Outstanding reimbursements total \$579,000, highlighting the need for follow-up to ensure cash flow continuity.

# V. Challenges & Opportunities

- Development of CHIP objectives and workplan in collaboration with partners for 2026.
- Inclusion of asthma prevention activities in the CHIP Prevent Chronic Disease priority area and completion of asthma epidemiological addendum for the community health assessment.
- DCHD continues to network with Neumann College of Nursing, ChesPenn, and the Delaware County Medical Society, specifically to augment access to primary care services in Chester City by a certified registered nurse practitioner (CRNP).
- Bio 200 Drill/Functional (Dispensing, etc.) Exercise Statewide Each CMHD must open and exercise a POD (PHEP BP2 requirement).

# VI. Upcoming Highlights/Success Stories

• DCHD received an urgent request on 11/17/25 to support the state's response to the MyHeart infant formula recall following 23 botulism-related hospitalizations, including one case in Pennsylvania. This outbreak involves an unusual botulism Toxin A strain, prompting state and federal partners to seek local assistance in conducting product audits to prevent further illness.

Within 24 hours, Environmental Health leadership developed and deployed a rapid audit plan, providing facility lists, standardized reporting language, and clear field instructions. The EH team conducted more than 80 inspections in just two days, delivering critical information to support the state's investigation. The team's swift and coordinated effort represents exemplary public health action and significantly contributed to protecting residents of Delaware County.



• Despite rainy weather, DCHD's 2025 Tinicum Drive Through Community Flu Clinic was highly successful. DCHD administered 161 vaccines—an increase from last year. Staff collaboration and teamwork and partnership with the Medical Reserve Corps was evident throughout the event, ensuring efficient and welcoming service to the community. The team maintained a high level of professionalism, leaving the firehouse in excellent condition and exercising mobile field operations efficiently and effectively.

DCHD's Environmental Health Specialists Tracy Spicer and Leslie Gaymon delivered an
outstanding inaugural food safety class for nonprofits in October 2025. Their extensive
preparation and thoughtful execution resulted in a highly successful and well-received
training. Offering a no cost food safety class for non-profit organizations has been a goal of
DCHD since the department's inception.

DCHD continues to assist Delaware County residents navigate care options and obtain their medical records from the Crozer Health system. DCHD assisted 31 seniors with their medical records in just a few hours at a Crozer Records event at the Keystone Wellness Center in October, bringing the total number of residents supported through this initiative to more than

250.
