MONTHLY POLICE BLOTTER

*The below captions are a summary of significant police responses during the listed month. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

December

- **12/01/2025 0929hrs - Narcotics Possession**

Officers assigned to the Courthouse Complex discovered a bag of suboxone on an individual checking into the Courthouse. The individual was unable to provide a prescription for the items. Officers confiscated the narcotics and the individual's information was noted and the individual was advised to come back by end of business the same day with proof of his valid prescription.

- **12/01/2025 1014hrs - Wanted Person**

Officers assigned to the Upper Darby Probation Office were notified of a wanted individual with an active warrant. Officers took the individual into custody without incident.

- **12/01/2025 1302hrs - Disturbances**

Officers assigned to the Courthouse Complex were approached by an individual requesting an escort to the Office of Judicial Support. The individual requesting the escort advised that they had an active protection from abuse order against another individual in that area who attempted to make contact with the reporting individual. Officers escorted individual #1 to OJS and found the 2nd individual who was then escorted off property after information had been attained by all parties. Officers then gave all the information to the detective division.

- **12/01/2025 1340hrs - Panic Alarm**

Officers assigned to the Courthouse Complex received a Panic Alarm from the Office of Judicial Support (OJS) and promptly responded. Officers found an individual in the office who had been trying to file paperwork and had been informed it was the wrong office. The individual became irate and refused to leave. Officers obtained the individual's information and escorted them off property.

- **12/01/2025 1645hrs - Medical Emergency**

Officers assigned to the Fair Acres Division were dispatched to a report of a Medical Emergency for a resident having trouble breathing. Officers responded promptly along with Emergency Medical Services (EMS). EMS evaluated the resident, but transport was not needed at the time. Officers gathered all relevant information and a report was filed.

- **12/02/2025 1026hrs - Medical Emergency**
Officers assigned to the Fair Acres Division were dispatched to a report of a Medical Emergency. Officers and Emergency Medical Services (EMS) responded promptly, and the resident was transported to a local hospital (ED) for further evaluation and treatment. Officers gathered all relevant information after assisting and cleared.
- **12/02/2025 1727hrs - Medical Emergency**
Officers assigned to the Fair Acres Division were dispatched to a report of a Medical Emergency (Fall). Officers and Emergency Medical Services (EMS) responded promptly, and the resident was transported to a local hospital (ED) for further evaluation and treatment. Officers gathered all relevant information after assisting and cleared.
- **12/03/2025 1129hrs - Narcotics Possession**
Officers assigned to the Courthouse Complex found suboxone strips and drug paraphernalia with the odor of Marijuana emanating from it on an individual checking into the Courthouse. Officers recorded the individual's information and informed them all the items were being confiscated. The individual was also notified if they could produce a valid prescription they could come back and retrieve the medication/narcotic from the Detective division.
- **12/03/2025 1253hrs - Narcotics Possession**
Officers assigned to the Courthouse Complex discovered strips of Suboxone on an individual checking into the Courthouse. The individual could not produce a prescription leading to the Suboxone being confiscated by the Officers and the individual's information being recorded. Officers informed the individual if they could provide a valid prescription they could come back and receive the Medication/Narcotics from the Detective Division.
- **12/03/2025 1633hrs - Medical Emergency**
Officers assigned to the Fair Acres Division were dispatched to a report of a Medical Emergency (Trouble Breathing) and along with Emergency Medical Services (EMS) promptly responded. EMS evaluated and transported the patient/Resident to the local Hospital (ED) for further evaluation/treatment. Officers assisted and had recorded all relevant information prior to clearing the call.
- **12/04/2025 0845hrs - Domestic Disturbance**
Officers assigned to the Courthouse Complex were approached by an individual who advised they had a PFA (Protection from Abuse order) against another individual who was on location. The other individual had attempted to speak with this individual who had the PFA. Officers separated all parties and recorded all relevant information. All parties were kept separated without further incident.
- **12/06/2025 1756hrs - Burglary Alarm**
Officers assigned to Parks Patrol were dispatched to a building alarm in the Cardinal Kroll Center Building. Park Patrol responded and could hear an audible alarm from outside the building. Officers checked all exterior entrance and exit doors to find the building secured. Officers then made entry into the building and cleared it floor by floor resulting in negative findings. The alarm was reset, and officers cleared the call.

- **12/06/2025 2047hrs - Suspicious person**
Officers assigned to Parks Patrol found an occupied vehicle within Smedley Park after hours. Officers conducted a traffic stop and advised the occupants of the county park ordinance violation. The occupants were released shortly after this with a verbal warning.
- **12/08/2025 0540hrs - Medical Emergency**
Officers assigned to the Fair Acres Division were dispatched to a report of a medical emergency (abdominal pain). Officers along with Emergency Medical Services (EMS) promptly responded and EMS evaluated/treated the Patient. Officers stayed on location to assist and record all relevant information prior to EMS transporting the patient to the local hospital (ED).
- **12/08/2025 0914hrs - Weapons Possession**
Officers assigned to Courthouse Complex discovered a taser on an individual while screening them in. Officers recorded the individual's information and confiscated the taser and advised the individual that the item is a prohibited offensive weapon. The individual's information was taken and they were released with a verbal warning.
- **12/08/2025 1100hrs - disorderly Conduct**
Officers assigned to the Courthouse Complex were notified of an individual who was sitting in on a court hearing and began to become irate and began yelling and screaming. Responding officers made contact with the individual and advised them to leave. The individual complied with the officers and was escorted off property after officers obtained their information.
- **12/08/2025 1443hrs - Medical Emergency**
Officers assigned to the Fair Acres Division were dispatched to a medical emergency (Diabetic Emergency). Officers along with Emergency Medical Services (EMS) promptly responded and EMS evaluated/treated the Patient. Officers stayed on location to assist and record all relevant information prior to EMS transporting the patient to the local hospital (ED).
- **12/09/2025 0944hrs - Suspicious Package**
Officers assigned to the Courthouse Complex received a report of a suspicious package left against a tree on the orange St. side of the complex/property. Officers promptly responded and after it was determined safe to touch/move the bag it was brought back to Park Police headquarters. Findings were negative and a report was filed.
- **12/09/2025 1301hrs - Suspicious Person/Disturbance**
Officers assigned to the Courthouse Complex received a call for a suspicious person creating a disturbance in the Fronefield Building. The Individual was yelling and using profanity outside of one of the courtrooms. The individual was claiming that the police had hacked into his phone and phone apps and that everywhere he goes the police are watching him. Officers on location called for mobile crisis while attempting to de-escalate the situation. The individual never claimed to want to hurt others or himself and after talking with mobile crisis left the property without further incident.

- **12/10/2025 1400hrs - Report of theft**

Officers assigned to the Fair Acres Division received a report from a resident about possible stolen or missing money from her room. The resident claimed the money was last seen a week ago. Officers recorded all relevant information and notified the Detectives. Upon a follow-up the resident advised that the missing money had been found.

- **12/11/2025 1134hrs - Disturbances**

Officers assigned to the Courthouse Complex received reports of a disturbance inside of one of the offices within the complex. Officers promptly responded and found that two individuals were there for a meeting with a case worker. One of the individuals was escorted out of the building after allegedly making threats prior to the officer's arrival. All relevant information was gathered, and Officers asked the individual who was threatened if they wanted to file for a PFA (Protection from abuse order) and after the individual advised they did they were escorted to the OJS (Office of Judicial Support) office to file it without further incident.

- **12/11/2025 1414hrs - Assault**

Officers assigned to the Courthouse Complex heard a loud commotion coming from outside of one of the courtrooms in the Fronefield Building. Responding Officers found two individuals being held back from one another by bystanders. Officers immediately separated all parties and began an investigation to determine what happened. One individual did not want to initially speak but later admitted to assaulting the 2nd individual. The now suspect was taken into custody and processed. The 2nd individual was found to be the victim after CCTV footage. EMS was called for the victim for an evaluation at their request. The suspect, who was a juvenile, was released to family with juvenile charges being petitioned by detectives.

- **12/12/2025 1406hrs - Narcotics Possession**

Officers assigned to the Courthouse Complex found multiple bags of a green leafy substance on an individual while screening them in. The individual admitted that it was marijuana. The marijuana was confiscated, and the individual's information was recorded before being released. Officers submitted the confiscated marijuana to be destroyed.

- **12/13/2025 1954hrs - Damage to County Property**

Officers assigned to Parks Patrol were dispatched to an alarm at Delco Woods. Upon their arrival, officers found a shed's door opened and items moved around that had not been previously moved. Officers conducted a thorough search of the entire property as well as making entry into the building and found nothing else in the building. Another building was found to have shattered glass and after making entry officers reset the alarm and again found nothing. Maintenance was notified and all buildings were re-secured.

- **12/15/2025 1113hrs - Disorderly Conduct**

Officers assigned to the Courthouse Complex were dispatched to stand by for a PFA conference between two parties. While on location one individual began yelling and became irate while insulting others in the conference room. The individual then stood up while pulling his phone and recorded with it. The individual was informed that he could not record or take pictures while in the conference area and during the conference itself. The individual then attempted to leave the area and was detained by officers. The individual resisted with officers and threw themselves down on the floor claiming they needed medical attention. Officers were able to restrain the individual and called for EMS for the individual per their request. While attempting to assist the individual up, they continued yelling and trying to get away from officers by kicking two officers with their feet. The individual was escorted by officers via an ambulance to the hospital for evaluation. Once medically cleared the individual was transported back to Park Police Headquarters to be processed and charged.

- **12/16/2025 1230hrs - Warrants**

Officers assigned to the Upper Darby Probation Office took an individual into custody for a Violation of Probation warrant. The individual complied with officers and was transported to George W. Hill Correctional Facility for processing and housing.

- **12/16/2025 2055hrs - Disturbances**

Officers assigned to the Fair Acres Division were dispatched for a report of an agitated and possibly combative resident. Officers arrived on location to find a resident who was extremely agitated. Officers on location were able to calmly de-escalate the situation with no incidents.

- **12/18/2025 0708hrs - Medical Emergency**

Officers assigned to the Fair Acres Division were dispatched to a medical alert activation for an individual near or possibly on Fair Acres property. Officers preformed a search of the entire Complex/property and the surrounding area yielding negative results. The call was unfounded, and officers cleared the call after speaking with emergency communications center (911).

- **12/18/2025 2119hrs - Suspicious Person**

Officers assigned to Parks Patrol discovered an occupied vehicle in Upland Park after hours. Officers conducted a traffic stop and made contact with two individuals inside the vehicle to advise them of the county park ordinance violation. Officers gathered information before releasing the individuals with a county park ordinance citation.

- **12/19/2025 0930hrs - Medical Emergency**

Officers assigned to Parks Patrol were dispatched to a medical emergency inside the George W. Hill Correctional Facility. Officers arrived to find Emergency Medical Services on location as well. Officers gathered all pertinent information and cleared after EMS transported the Pt. to the local Hospital.

- **12/19/2025 1011hrs - Warrants**

Officers assigned to the Upper Darby Probation Office took an individual into custody for a Violation of Probation warrant. The individual complied with officers and was transported to George W. Hill Correctional Facility for processing and housing.

- **12/24/2025 1014hrs - Disorderly Conduct/Disturbance**

Officers assigned to the Courthouse Complex were dispatched to a panic alarm in the Office of Judicial Support (OJS). Arriving officers were directed to an individual using obscene language and yelling at staff over a disagreement with filing paperwork. Officers were able to calm the individual down, obtain information from them, and escort them out of the building for the day without further incident.

- **12/25/2025 2300hrs - Suspicious Person**

Officers assigned to Parks Patrol discovered an occupied vehicle at the Delco Woods property during a routine patrol. Officers conducted a traffic stop on the vehicle and made contact with the individual inside the vehicle to advise them of the county park ordinance violation. Officers gathered information before releasing the individual with a verbal warning.

- **12/26/2025 0833hrs - Medical Emergency**

Officers assigned to the Fair Acres Division were dispatched to a medical emergency. Officers promptly responded to the location along with Emergency Medical Services (EMS). Officers assisted as needed and gathered all pertinent information. EMS transported the Patient to the local hospital and officers cleared the call.

- **12/27/2025 0815hrs - Medical Emergency**

Officers assigned to the Fair Acres Division were dispatched to a medical emergency. Officers promptly arrived on location followed shortly by Emergency medical services (EMS). Officers and EMS talked with the patient and the nursing staff gathering all pertinent information. Officers assisted as needed until EMS transported the Patient to the local hospital.

- **12/29/2025 1234hrs - Narcotics Possession**

Officers assigned to the Courthouse Complex metal detectors discovered a green leafy material in a sealed container on an individual while screening them into the courthouse. The container was confiscated, and officers obtained all pertinent information on the individual prior to letting the individual go with a verbal warning.

- **12/29/2025 1530hrs - Disturbances**

Officers assigned to the Fair Acres Division were dispatched to a report of an incident that had occurred between two individuals. Following the incident, one of the individuals was barred for the time being from re-entering the property. Officers assigned to the Fair Acres Division were made aware and no further action has been noted or taken at this time.

- **12/29/2025 1551hrs - Hazardous Conditions**

Officers assigned to Parks Patrol were dispatched to Smedley Park for hazardous conditions. Arriving officers found a tree down in the roadway along with downed power lines. Officers immediately had Parks Dept. and PECO dispatched to assist. Both departments arrived within minutes and began work on removing the hazards. Officers remained on location to create a safety buffer for both the workers and the public until the hazard was cleared.

- **12/30/2025 0751hrs - Warrants**

Officers assigned to the Upper Darby Probation Office took an individual into custody for a Violation of Probation warrant. The individual complied with officers and was transported to George W. Hill Correctional Facility for processing and housing.

- **12/30/2025 0900hrs - Assist other Agencies**

Officers assigned to Parks Patrol provided mutual aid to a neighboring agency for a medical emergency involving a juvenile. Responding officers assisted with manpower and traffic control for all emergency personnel on scene. Park Police Officers remained and assisted until the emergency was concluded.

- **12/31/2025 1000hrs - Possible weapons/confiscated items**

Officers assigned to the Courthouse Complex discovered two rocks and a bag of metal bolts on an individual as they were being screened into the courthouse. One of the rocks was placed inside a sock. Officers confiscated the items after determining that they could be used as an offensive blunt force weapon. Officers also gathered all relevant information on the individuals prior to them leaving the courthouse.

- **12/31/2025 2120hrs - Medical Emergency**

Officers assigned to the Fair Acres Division were dispatched to a medical emergency. Officers promptly responded along with Emergency Medical Services (EMS). Officers stayed on location to assist EMS and gather all pertinent information. EMS transported the patient to the local hospital and officers cleared the call.
