Special Instructions for Pick-Up

25 P.S. §2687 Appointment of Watchers:

(a) Each candidate for nomination or election at any election shall be entitled to appoint two watchers for each election district in which such candidate is voted for...

(b) Each watcher so appointed must be a qualified registered elector of the county in which the election district for which the watcher was appointed is located...Watchers shall be required to show their certificates when requested to do so. Furthermore, an elector seeking public office may not be a Watcher anywhere that their name appears on the ballot.

25 P.S. §3502 Perjury:

Any willful false statement made under oath or affirmation or in writing, statement that it is so made, although such oath or affirmation may not have actually been made, by any person regarding any material matter or thing relating to any subject being investigated, heard, determined or acted upon by any county board of elections, or member thereof, or by any court of judge thereof, judge of election, inspector of election, or overseer, in accordance with the terms of this act, shall be perjury...

**25 P.S. §2687 Appointment of Watchers:**

The Delaware County application for watcher's certificate by a candidate offers the candidate the ability to apply for fifteen (15) certificates on one application. Please list the **watcher's name**, their **registered address**, the **community where you are requesting them to be a watcher** and the **division**. For example:

Additional points to follow when completing the application for watcher certificates are:

- Candidate should indicate at the top of the form in the section labeled **“Special Instructions for Pick-up”** who specifically the candidate wishes the Bureau of Elections to release processed watcher certificates to. If this section is left blank, certificates will be released to whoever requests them.
- When completing the watcher information, the Bureau requests that the **information is typed**. This method will allow for more accurate processing.
- If applying for a large number of watcher certificates the Bureau requests the candidate **organize applications by town**, grouping one community together on applications.
- Application must include the **candidate's original signature** at the bottom right corner of the application (or the designated agent). To do so the candidate must send correspondence to the County Bureau of Elections indicating the office they are seeking and identify their appointed representative. The notice must be dated and signed (**original signature**) by candidate. Once this notice is filed in the Bureau of Elections the representative may sign the applications for watcher certificates.

Applications for watcher certificates may be submitted to the Bureau from September 30, 2025 through November 4, 2025. The Bureau encourages **application for certificates by October 31<sup>st</sup>** to allow sufficient processing time. Certificates requested on October 31<sup>st</sup> will be available November 3<sup>rd</sup> after 12 pm. **Requests made after 12 pm on Nov 3<sup>rd</sup> will be available after 11 am on November 4<sup>th</sup>. Requests made on November 4<sup>th</sup> will be made available as time allows.**
