# 09/25/2025 Delaware County Board of Health Meeting Delaware County Department of Health Status Report

Reporting Period: June - August 2025

#### **I. Executive Summary**

DCHD continues to strengthen its role as a trusted public health leader while navigating ongoing workforce and system challenges. From June through August 2025, the department continued its progress in surveillance, program delivery, and infrastructure modernization, while also receiving national recognition for its innovation and impact.

#### **Key Achievements**

- **Epidemiology & Surveillance** Monitored increased ED utilization following the Crozer closure, seasonal COVID-19 trends, and seasonal tickborne and mosquito-borne illnesses. No measles cases were reported in Delco to date in 2025. Expanded data integrity efforts by reconciling differences between Census and PA DOH population data for age-adjusted rates.
- Maternal & Child Health Completed Title V projects, including serving over 40 individuals with doula support, training 8 doulas, conducting student needs assessments, and hosting prenatal and postpartum peer support groups over the July 2024-June 2025 grant year period. In addition, DCHD hosted a Maternal Wellness Workshop on July 26 in Chester that successfully promoted maternal mental health and wellness.
- Immunizations & Clinics Delivered over 275 vaccines at Chester and Yeadon August back-to-school events and continued to support Hep A/B vaccination efforts at Harwood House community-based residential treatment program. DCHD's Yeadon and Chester clinics together served more than 200 patients for routine immunizations over the June-August reporting period.
- **STI/HIV Services** Began supporting George W. Hill Correctional Facility with STI testing to reduce county costs; conducted 249 tests through August. Established a new testing partnership with Widener College. Clinics in Chester and Yeadon collectively treated ~65 patients in August.
- **Test & Go Initiative** Distributed 476 public health products in August, with high utilization at 69th Street Transit Center. This nationally recognized program was featured at the NACCHO360 conference as a best practice in prevention and access.
- National Recognition DCHD was awarded a 2025 NACo Achievement Award in the category of "Forming a Health Department," affirming its progress as one of Pennsylvania's newest health

departments and highlighting its success in building sustainable public health infrastructure.

#### **Challenges & Opportunities**

- Workforce & Retention DCHD employed 85 staff during the quarter, with 16 separations through August 2025. Competitive compensation continues to drive resignations, particularly among clinical staff, as employees seek higher-paying opportunities.
- **Hiring Freeze** A countywide hiring freeze remains in effect until the end of 2025, limiting replacements. Strategic exemptions are being pursued for high-need roles, including a Data Analyst, Medical Assistant, and Communications Specialist, alongside nursing positions.
- **Employee Engagement & Morale** In collaboration with consultant Dr. Motley, DCHD is developing an employee engagement framework to improve morale, promote retention, and prepare staff for the administrative division's relocation to Yeadon Wellness Center.
- **Fiscal Role Realignment** Leadership is reviewing current fiscal roles and responsibilities to improve functionality, streamline processes, and ensure clearer delegation of duties across divisions.

# **Infrastructure & Systems Modernization**

- Facility planning is underway for administration's move to the Yeadon Wellness Center and relocation of Environmental Health (location TBD).
- IT/Data modernization includes expansion of Freshworks for call center and contract management, AchieveIT integration of the 5-year Strategic Plan, and JotForm replacing Qualtrics for surveys.
- Fleet operations were strengthened through cross-training, and the Mobile Health Unit is now expected in October following supply chain delays.
- Contributed to the County's Recycling Study, supporting sustainable waste management and compliance with state recycling requirements.

#### **Looking Ahead**

- Onboarding eight staff members in September, including one re-instatement.
- Launch of expanded STI testing with Widener College in October.
- Continued maternal health equity initiatives focusing on reducing Black–White disparities.
- Implementation of cold-weather preparedness protocols and fall flu clinics.
- Rollout of the Strategic Plan in AchievelT and onboarding of new staff.

#### **II. Programmatic Updates**

# **Epidemiology:**

#### **Health Systems & Utilization**

• **Crozer Closure Impact:** Emergency department (ED) visits at the two remaining Delco hospitals show an upward trend, confirmed by EpiCenter data and hospital reports.

#### **Reportable & Seasonal Diseases**

- Respiratory Illnesses: DCHD updated its <a href="https://delcopa.gov/health/respiratory-illnesses">https://delcopa.gov/health/respiratory-illnesses</a> page with 2025-2026 information. COVID-19, influenza, and RSV wastewater levels remain low. COVID-19 case counts are increasing, following the dual summer/winter seasonality pattern. Drivers include variant changes, waning immunity, and increased indoor gatherings.
- **Vector-borne Illnesses:** Observing routine seasonal rise in tickborne and mosquito-borne disease activity, including one confirmed human case of West Nile virus with neurological complications this year compared to two confirmed and three suspected human cases last year.
- **Measles:** No Delco cases in 2025; investigated recent suspected exposures but these were found to be Chester County residents.
- **Mpox**: There have been recent wastewater detections for Mpox at the Delcora Western Wastewater Treatment Plant (1 positive sample in untreated wastewater, September 4) and in Philadelphia. In September 2025, DCHD also had its first Delaware County MPox patient since August 2024.

#### **Data Integrity & Methods**

- Identified discrepancies between PA DOH EDDIE and Census data in calculating age-adjusted rates; differences are minor but must be explained in reports.
- This difference was communicated with the PA DOH office of vital statistics.

#### **Community Engagement, Outreach / Networking**

- In coordination with Chester City Health Commissioner, proposed environmental justice theme and shared Chester City air emissions data with leadership from the Cancer and Environmental Network of Southeastern PA / Pennsylvania Cancer Coalition for upcoming state meeting.
- Created and shared summarized results from the 2025 DCHD Breast Cancer survey with the Chronic Diseases Community Health Improvement Plan (CHIP) workgroup (686 responses see details below).
- Presented methodology for heart disease hot spot identification to state and county epidemiologists.
- Mentored Drexel MPH intern on age-adjusted mortality analysis and GIS mapping.

#### **Infectious/Communicable Disease Investigations**

- Conducted weekly vector-borne illness surveillance (counts, trends, and visualization).
- Managed > 60 animal bite reports (including multiple bat exposures, dog bites, and cases involving unvaccinated animals), coordinated >20 lab results, and provided cross-jurisdictional support with NJ, PA, and DE.
- Opened/closed COVID-19 outbreaks at Fair Acres (3 cases) and Whitehorse Village (15 cases), plus Wallingford Skilled Nursing Facility.
- Investigated and closed an infant botulism case (ultimately ruled out).
- Evaluated Legionella, RMSF, Cryptosporidium, and West Nile virus surveillance updates.
- Consulted on hand, foot, and mouth disease cases in daycares, drafted prevention resources and parent notification letters.
- Discussed OXA-23 CRAB cases at Providence Rehab and reviewed infection control responses.
- Engaged in Hepatitis surveillance improvement: performed data quality audits on women of childbearing age, reviewed case definitions, and discussed priority schema.

#### **Maternal & Infant Health**

- Continued emphasis on reducing Black–White disparities in maternal and infant outcomes.
- Recommendation: build community action networks focused on preconception health, addressing social determinants, and holistic prevention.


#### **Epidemiological Summary**

- Between MMWR Weeks 1–34, 2025 shows notable increases in several conditions compared to the same period in 2024.
- The largest rise was seen in RSV (+322 cases), followed by Hepatitis C Past/Present (+90), Lyme disease (+17), and syphilis categories including late/unknown (+11) and carbapenemase-producing organisms (CPO) clinical isolates (+8).
- The greatest decreases occurred in Chlamydia (–359 cases), Pertussis (–126), Gonorrhea (–97), Hepatitis B Chronic (–47), and Campylobacter (–9).


#### Test & Go Kiosks:

- 476 dispensations (47% at 69th Street Transit Center).
- Most common items: condoms (32%), first aid kits (27%), and emergency blankets (16%). Majority of visitors were women (44%); African Americans were the largest group served (40%).

# 1) Dispenses by Location




# 2) Demographics (note: only displaying counts above 10)




# Flu Death Crude Rates by Municipality 2023

Number and Rates Flu Deaths Delco 2023





# **Public Health Emergency Preparedness**

- Developing County cold weather criteria for cold blue versus extreme code blue; working collaboratively with other county agencies
- Flu Clinic planning for the fall 2025 season has commenced; locations will be Tinicum Fire Company (10/12/25), Keystone First (10/21/25), and Murphy's Giving Market (10/7/25). Reached out to Sikh Temple as an additional potential location.

# **Community Health Improvement Plan (CHIP)**

- Each of the three CHIP priority committees have been meeting for one year at this point. DCHD is
  working with partners to reflect on the current status of initiatives and reconnect with community
  partners. Phone calls are being planned with committee members to identify opportunities for
  improvement, relevant agency-specific work that should be included in the CHIP, and to obtain ideas
  for how to optimize committee involvement.
- Development of a CHIP Achieve It dashboard is in progress.

• DCHD staff involved in each of the three committees are researching policy-level work conducted by other local health departments specific to their topic areas that we will use to identify potential speakers for the team and DCHD staff.

# **Accreditation Readiness (PHAB)**

- We met with PHMC and one of their contractors to identify tools and resources that can assist DCHD (as well as other LHDs in PA) in initial steps to take as they pursue accreditation.
- A listing of all documentation needed for accreditation has been obtained for internal reference.
- There are many elements required by the accreditation process, however, the most labor-intensive documentation that health departments must submit are driven by eight plans. Additional policies, processes, and efforts must be demonstrated, but completion of these eight plans is the first recommended action for health departments seeking accreditation. The eight plans are outlined in the table below, as well as an inventory of the status of DCHD's plans as of August 31, 2025. Of the 8 required plans, 3 are complete, 3 are underway, and 2 have not been started.
- As part of a preliminary accreditation readiness review process, 2 of the 8 major plans were reviewed and recommendations have been submitted to managers in their respective program areas.

# **Personal Health:**

### **STI/HIV Services**

- Assisted George W. Hill (GWH) Correctional Facility with 249 STI/HIV tests between July 17 and August 28. DIS staff provided partner services for positive results.
- Established a new partnership with Widener College to expand STI testing beginning October 2025.
- Yeadon and Chester STI clinics collectively treated ~65 patients across August, with continued outreach for prevention supplies.

### Maternal & Child Health (MCH)

- Title V Projects (FY24–25) concluded June 30:
  - Over 40 individuals served with doula services.
  - o 8 doulas trained through community partners.
  - 293 students assessed and 70 matched with assistive technologies.
  - Mental health and peer support services provided through Mommy Meet Ups and ongoing group sessions.
- Villanova graduated first Birth Companion cohort (11 graduates); work underway to link them with county residents.
- Maternal Wellness Workshop (July 26) successfully delivered education on maternal mental health, yoga, and linkage to resources.

# **Immunizations & Community Clinics**

- Back-to-School Events:
  - Chester (8/9): 78 physicals, 22 dental screenings, 22 children vaccinated (51 vaccines).
  - Yeadon (8/16): 23 children served with 96 vaccines administered.
- Routine Clinics (6/1–8/26): Yeadon (183 patients), Chester (28 patients).
- Ongoing support of Hepatitis A/B vaccination at Harwood House Recovery Home.

#### **Lead & Environmental Health**

- 125 open lead cases; increase in children testing ≥10 µg/dL (4 cases vs typical 1–2).
- High-priority complicated case in Chester remains unresolved despite remediation; active coordination with Keystone First, ChesPenn, and PA DOH.
- New Iron Man

  —themed lead awareness poster distributed at community fairs and early childhood programs.
- System improvements underway: provider notification letters, enhanced referral tracking, and better alignment with insurers.

#### **Tuberculosis**

16 active TB cases with ongoing management.


#### **Environmental Health:**

- Working with PDA on developing a non-profit food volunteer class through DCHD EH.
  - o Final draft complete and approved internally.
  - Will work with solicitor for approval of plan (certificate, no cost, liability, etc).
  - Still researching opportunities for first class.
- Team working to expand the Daily Audit reports to include complaints responses. Also, the possibility
  of a weekly or monthly performance report for each region.
- Working with USDA on 2 Delco facilities that are not able to provide documentation that the food they
  are selling is from an approved source.
  - USDA issued Citations for both facilities. Product was removed from stores. DCHD will perform follow-up inspection to verify product is not being sold.
- EH working with BOH to review/update BOH codes.

#### Food & Other Inspections – June to August 2025

- June (6/1–6/26): 363 inspections (327 food, 36 other).
- July (7/1–7/30): 351 inspections, all food-related.
  - o Higher number of plan reviews (57) and complaints (24) compared to June and August.
- August (8/1–8/31): 377 inspections (294 food, 83 other).
  - Marked increase in pool inspections (67) and institutional inspections (25), reflecting seasonal summer activity.

Key Takeaway: While inspection volume remained consistent across all three months, the focus shifted—with July emphasizing food service plan reviews and complaint investigations, and August showing a seasonal surge in pool and institutional inspections.




## **Vector Surveillance – June to August 2025**

• Adult Mosquitoes: Peaked in July (950 collected), compared to 375 in June and 275 in August.

- Mosquito Larvae: Highest in July (650), while both June and August had 150.
- Ticks: Steadily increased, from 30 in June, to 62 in July, to 100 in August.


#### Key Takeaways:

- July was the most active month for mosquito populations, coinciding with 5 positive West Nile Virus (WNV) samples and multiple larval control events.
- Tick activity peaked in August, with all drags completed for the season and testing ongoing at the state lab.
- Surveillance results guided interventions, including a scheduled ULV spray event on 9/2/25 in Brookhaven, Upland, Parkside, and Chester City.

- Planning underway for Administrative Division move to Yeadon Wellness Center, with minor construction and realignment of staff (e.g., integrating DIS and Population Health).
- Reviewing relocation options for Environmental Health Division with County Real Estate.
- Ongoing facility maintenance: odor issues in Yeadon, lighting replacement, pest remediation at Baldwin Tower, and work orders for Chester and Yeadon Wellness Centers.

#### **IT & Data Systems**

- AchievelT: Implementation of DCHD's 2025–2030 Strategic Plan entered into platform; analysis of task assignments and reporting underway.
- CDP EMR: Intake form fully tested; Language Line video in testing; County IT adding new iPad security software.
- Freshworks Call Center: Configured and tested; next steps include staff training, data migration, and dashboards. Planned expansion into contract management, facilities requests, and MCH intake.
- JotForm: Contract renewal secured; DCHD configuration to begin in September (will replace Qualtrics).
- Workday: County-wide rollout still delayed (status RED); DCHD warehouse inventory testing to begin September.

#### **Fleet**

- Mobile Health Unit: Production continued to be delayed due to supply chain issues; pre delivery site inspection targeted for October/November with delivery of vehicle in late November/December 2025 at this time.
- Fleet Training: Cross-training completed to ensure operational continuity in fleet management.

#### **County Recycling Study**

• DCHD contributed data to County Office of Sustainability for development of new trash/recycling program. Findings show much staff waste is recyclable; County plans to shift to recycling bins at desksides with centralized trash collection.

#### V. Challenges & Opportunities

#### **Workforce & Staffing**

- DCHD employed 85 staff during the quarter, with 16 separations through August 2025. A countywide hiring freeze is in effect. Exemptions have been granted for nursing positions.
- DCHD is seeking additional exemptions to backfill critical roles including Data Analyst, Medical Assistant, and Communications Specialist to maintain operational effectiveness.
- Employee departures are largely tied to opportunities offering higher pay and flexibility. DCHD is working on efforts to strengthen retention, improve workplace culture, and support staff through the upcoming changes in the year ahead.
  - In September 2025, DCHD updated the department's prior "ad hoc" only remote work policy with a formal hybrid work policy permitting up to one day per week routine remote work for applicable positions.
  - DCHD is collaborating with consultant to design and implement an employee engagement strategy.

#### **Fiscal Operations**

- Leadership is actively reviewing fiscal roles and responsibilities to improve functionality, accountability, and clear delegation of duties.
- This restructuring effort will support stronger financial oversight and streamline processes during a period of limited staffing capacity.

# **VI. Upcoming Highlights/Success Stories**

- On August 6, DCHD staff delivered a presentation at the Lansdowne Borough Lead Paint Community Forum. Special recognition goes to Mary Nixon, Shannon Dade, supported by Mary Craighead, Dr. Victor Rullan, Aminata Donzo, and Ariel Diehl for their contributions in preparation and delivery. The forum generated rich discussion around the risks of lead exposure and a proposed local ordinance aimed at prevention. This effort highlights the department's ongoing commitment to proactive strategies that prevent childhood lead poisoning and protect community health.
